CALENDAR DESCRIPTION: Studio based course at the intermediate level as independent study not normally available under existing courses for students who already have credit in AR4380. The focus is on self-initiated projects and research supervised by an instructor.

PREREQUISITE(S)/COREQUISITE: AR4380 and the consent of the department

REQUIRED TEXT/RESOURCE MATERIALS: no text, material as required by student's proposal

DELIVERY MODE(S): lecture/lab

COURSE OBJECTIVES: This course offers further development of the following:

- 1. The opportunity, with the guidance of an instructor, to explore, develop and produce a body of work specific to their discipline and interests.
- 2. Skills to write a professional artist's statement addressing the content around the work.
- 3. A year-end exhibition of chosen work in a professional setting.
- 4. Ongoing meetings with both the instructor and peers to critique and share ideas.

LEARNING OUTCOMES: The student at the end of the course will:

- 1. Further develop the ability to work independently in a studio setting
- 2. Further develop a personal visual language and approach to making work.
- 3. Have a strong body of portfolio work to take forward and use to further a BFA program or start a professional art practice.

4. Have enhanced critique skills as a result of ongoing studio critical dialogue.

EVALUATIONS:

- 1. Level of engagement: the student must be highly engaged with both the process and the content of the work.
- 2. Completion of assigned tasks as per course criteria: Images, statement, exhibition,
- 3. Quality of work: This includes the level of creativity and craftsmanship demonstrated and the degree of knowledge and understanding of the elements and principles of this particular studio discipline.
- 4. Ongoing presentation of the work will be required throughout the duration of this course.

First-Term Grading:

First-term grading is by portfolio. It constitutes **40%** of the final grade. The portfolio will be presented in an individual critique format with the instructor in the back of Studio B. Overdue portfolios will be penalized a minimum of 1 grade point per late day.

Second-Term Grading:

Second-term grading is by portfolio. It constitutes **60%** of the final grade. The portfolio will be presented in an individual critique format with the instructor in the back of Studio B. Overdue portfolios will be penalized a minimum of 1 grade point per late day.

Final Grade will be determined by portfolio/exhibition.
