CD1145 Practicum Guidelines

**CALENDAR DESCRIPTION:**

This is normally an eight week practicum in an early childhood setting. Students will have the opportunity to apply theory to practice in their work with young children. Students will spend time in the Children’s Centre Demonstration Program as a component of this practicum and will attend weekly seminars throughout the practicum weeks.

### **DELIVERY MODE(S):**

This practicum course consists of practical experiences with children in community programs such as child care centers, preschools, family day home, kindergartens, and special placement.

The practicum seminar provides a forum for students to integrate theory with practice and to reflect and explore issues related to the field of early childhood education, their studies and their practicum experiences. **Students are required to actively participate in discussions.**

### **OBJECTIVES (OPTIONAL):**

Upon successful completion of this practicum, the student will demonstrate:

1. increasing skills in developing a positive rapport with the children in the program.
2. increasing skills in interacting with children in a nurturing supportive manner.
3. skills in effectively guiding children's behaviour.
4. the ability to interact with individual and small groups of children with a growing awareness of how to facilitate, extend, and enrich children's play in a variety of play areas.
5. the ability to effectively plan, implement and evaluate experiences based on the developmental needs and interests of the children.
6. the ability to plan, implement, and evaluate learning centres.
7. beginning skills in planning and carrying out group times based on the developmental needs and interests of the children.
8. an awareness of the nutritional, health and safety needs of young children.
9. the ability to communicate effectively and work collaboratively with other adults.
10. professional behaviour.
