CALENDAR DESCRIPTION: This is normally a six-week practicum in a community early childhood setting such as a childcare center, nursery school, kindergarten, family day home or a special placement such as a play program for children in a woman's shelter or an early intervention program. Students will attend weekly seminars throughout the practicum weeks.

LOCATION/TIME: On Campus: Friday's 11:00 am – 12:50pm Room B 206 (October 30, 2023 – December 15, 2023). Off Campus: Various locations throughout the community.

PREREQUISITE(S)/COREQUISITE: CD2050, HS1217 and CD2380, Successful completion of Year 1.

REQUIRED TEXT/RESOURCE MATERIALS: None

DELIVERY MODE(S): This practicum course consists of practical experiences with children in community programs such as childcare centers, preschools, family day home, kindergartens, and special placement. The practicum seminar provides a forum for students to integrate theory with practice and to reflect and explore issues related to the field of early childhood education, their studies, and their practicum experiences. Students are required to actively participate in discussions.

LEARNING OUTCOMES:

Upon successful completion of this course, students will be able to:

- Demonstrate skills in interacting with individual and small groups of children in a nurturing, supportive, and responsive manner.
- Demonstrate more advanced skills in supporting, facilitating, and extending children's play.
- Demonstrate more advanced skills in guiding children's behaviour.
- Demonstrate skills in observing, recording, and interpreting children's behaviour.
- Effectively plan, implement and evaluate experiences based on the observed developmental needs and interests of the children.
- Effectively plan, implement and evaluate learning centres based on the observed developmental needs and interests of the children.
- Effectively plan, implement and evaluate group times based on the observed developmental needs and interests of the children.
- Demonstrate professional behaviour and communicate effectively with the other adults in the program. •
- Demonstrate skills in reflecting on and assessing her/his own behaviours and skills and set goals for further professional growth.

COURSE SCHEDULE/TENTATIVE TIMELINE:

Students attend practicum for eight hours per day Monday – Thursday at an approved licensed childcare environment. Seminars will occur every Friday for six weeks from 11:00 am – 12:50 pm.

SEMINAR IS MANDATORY: Absence more than 2 hours of seminar class will necessitate the negotiation of a learning contract with the instructor. Should the student fail to meet the terms of the contact, credit for this course may not be granted.

Extenuating circumstances may be considered on an individual basis.
