CALENDAR DESCRIPTION:

This course examines pirates and piracy in their political, economic, technological, and social context from antiquity to present. Particular attention will be paid to the role of the emerging state in defining, sanctioning, and punishing piracy; the role of gender and class in the social world of the pirate; and the social memory and popular image of the pirate.

COURSE OBJECTIVES:

This course intends to provide students with

- An understanding of the changing nature of piracy in world history and its major time periods
- Improved abilities to critically assess primary and secondary materials.
- Improved skills in collecting, interpreting, and presenting information.

LEARNING OUTCOMES:

- Students will be able to describe the major periods and significant turning points in pirate history.
- Students will be able to distinguish between the fictional portrayal and popular image of pirates and the historical reality.
- Students will be able to analyze historical work and recognize issues within it.
- Students will be able to formulate appropriate research questions; identify, select, and investigate appropriate primary and secondary sources; interpret the resulting information; and construct written responses in essay form.

Extensions will only be considered when students contact the instructor prior to the deadline and present evidence of extenuating circumstances.

Students will be assessed on their research, synthesis and writing in the course assignments. The presentation of information in terms of organization and writing will be given equal weight in grading to the research and analysis.

There will be two tests scheduled during the term and a final exam written during the exam period in December.
