1. Midterm Exam

The midterm exam includes all content covered up to and including Week 7. Question format includes a variety of styles including, but not limited to, multiple choice, short answer, long answer, matching, and select all that apply.

2. Clinical Judgement Exam

The purpose of this assignment is for students to demonstrate critical thinking through application of the nursing process to pediatric scenario(s). This Exam is an in-class, open-book exam. Students will have three (3) hours to complete. Students will receive case-study style question(s) about pediatric client(s) and their family. The students will have to clinically assess, diagnose, plan, implement, and evaluate their plan of care.

3. Seminar Participation

Seminar participation is essential for solidifying learning and application of knowledge shared in the theory class. Seminars may consist of activities to apply skills and critical thinking, alternative learning opportunities such as guest speakers and case studies. Students' preparation and participation in seminars will be evaluated according to the rubric on the myClass page.

4. Final Exam

The final exam includes all content covered in Weeks 8 -15. It is not cumulative. Question format includes a variety of styles including, but not limited to, multiple choice, short answer, long answer, matching, and select all that apply.

Scheduling of the final exam is set by the Registrar's Office.
